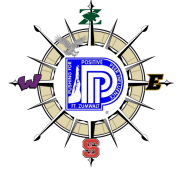

FZ One 1-to-1 Program Parent/Student Agreement



Student Use

I will:

- Be responsible for my Chromebook and take good care of it.
- Know where my Chromebook is at all times.
- Bring my Chromebook to school every day I am in attendance.
- Provide my own headphones or earbuds to use with the Chromebook.
- Make sure my Chromebook is charged every day.

Basic Care and Handling

I will:

- Know where my Chromebook is at all times; I will not loan it anyone else.
- Remember that I am responsible for my cord; if I loan it to someone else and it is lost or stolen, I am responsible for replacement.
- Keep my Chromebook in the condition I received it; I will not deface it by marking, painting, drawing, attaching stickers or marring any surface of the Chromebook.
- Transport the Chromebook securely closed.
- Remember not to leave my Chromebook unattended.
- Keep my Chromebook away from food/liquids and off the floor, where it could be stepped on or tripped over.

Expectations for Responsible Computing

I will:

- Keep my login and password information private and only share it with my teacher or parents/guardians.
- Use appropriate language in all digital products and communications.

Additionally:

- I will not give my name, address, telephone number, school, or my teachers'/parents' names, addresses or telephone numbers to anyone online.
- I will not fill out any form or sign up for anything online that asks me for information about my school, my family or myself without first receiving permission from my teachers/parents/guardians.
- I will not intentionally search for materials that are unacceptable in a school setting.
- I will not plagiarize. I understand this to mean that I will not use any portion of articles, stories or other works I find online and pretend they are my own.
- I will not use screensavers, backgrounds and/or pictures with offensive language and/or materials.
- I understand my Chromebook is subject to inspection at any time without notice and remains the property of the Fort Zumwalt School District.
- I will follow the expectations outlined in Board Policy EHB and EHB-R, the FZ One Student / Parent Handbook, and the Student Code of Conduct while at school, as well as outside the school day. A copy of EHB can be found at: <http://go.fzsd.us/PolicyEHB>

Parent/Guardian Agreement

- I acknowledge I will be responsible for any damage to the Chromebook as outlined in the Handbook. Incidents that occur at school involving multiple parties will be investigated by district administration.
- I acknowledge a mobile device fee is required annually before issuance of a device to my student(s).
